

SAFETY

These safety transformers are specifically designed to supply 12 VAC to Landscape, fountain, swimming pool and spa luminaires. Suitable for submersible luminaires.

- If installation involves running wire through a building structure, special wiring methods are needed.
- Do Not submerge transformer.
- Do Not exceed the maximum ratings of individual components, wiring devices, and current carrying capacity of conductors.
- Select power source by combining bulb wattage.




REMOVING KNOCKOUT


The LVX transformer supports the use of 1/2" and 3/4" conduit connections on the under side of the unit. When using 3/4" conduit connections, remove break away as shown.

1. Remove port caps from the required ports

- **2.** Using a pair of side cutters cut the internal ring supports
- **3.** Remove the internal ring from the conduit port.


INSTALLATION

Installation must comply with provisions of the National Electrical Code, ANSI/NFPA 70, including those in Article 680 - Swimming Pools, Spas, Fountains and Water Features.

- For field wiring information, please refer to the instructions attached to inside of front cover.
- Make sure that all unused taps (leads) are separately insulated.
- The voltage at lamp terminals after installation should be 12 ± 1.0 VAC.

Landscape Lighting:

The low-voltage wire or cable extending from the power-unit output circuit to, and between, the individual luminaires and fittings is intended to be certified SPT-3, SPT-2W, a junior or hard service cord (SJTW, STW, or similar) underground low-energy circuit cable, or other wire or cable rated as sunlight resistant, suitable for wet locations, and intended for direct burial.



Power supplies are for outdoor use only.
